# Liquefied Petroleum Gas Board Minutes January 11, 2018

The Alabama Liquefied Petroleum Gas Board held its quarterly board meeting on January 11, 2018 at 10:00 a.m. at Auburn University Montgomery Center for Lifelong Learning, 75 TechnaCenter Drive, Montgomery, AL.

#### ATTORNEY GENERAL'S OPINION ON LPG FEE INCREASES/DECREASES

Code of Alabama 9-17-106(j) Any supplier who sells liquefied petroleum gas to any marketer or any end user in the state or who delivers or causes to be delivered liquefied petroleum gas to any point in the state, shall report to the board all sales by the twentieth of the month following the month in which the sales are made. Each supplier shall add to each individual sales invoice an LP-gas fee not to exceed one-half of one cent per gallon. This fee shall be submitted to the board only once per gallon. Each supplier shall remit to the board all LP-gas fees due with the required monthly reporting form provided by the board. The board may lower or raise the LP-gas fee imposed by this article. At no time may the board raise the LP-gas fee imposed by this article above the rate of one-half of one cent per gallon.

With particular emphasis on the underlined portion of code above, is the Alabama Liquefied Petroleum Gas Board authorized to lower or raise the LP-gas fee at a meeting scheduled in accordance with the Alabama Open Meetings Act or must the board go through the rule-making process pursuant to the Alabama Administrative Procedure Act?

(12) Mr. Jones moved to request a formal Alabama Attorney General Opinion on the question presented related to the raising or lowering of the LP-gas fee by the board. Seconded by Mr. Ferguson, the ayes were unanimous.

### **TESTING SPACE LEASE**

The Administrator presented a lease for office space from the State of Alabama Department of Finance, Division of Risk Management-State Insurance Fund for use as a examination site for industry employees.

(13) Mrs. Barnett moved to approve the State of Alabama Department of Finance, Division of Risk Management-State Insurance Fund's lease for office space. Seconded by Mr. Ferguson, the ayes were unanimous.

#### SETTLEMENT AGREEMENT 2018-01

Mid-South Propane in Florence, AL (hereinafter referred to as "Respondent") hereby stipulates and agrees, subject to ratification by the Alabama Liquefied Petroleum Gas Board (hereinafter referred to as "the Board") to the following:

#### STIPULATED FACTS

1. Respondent extracted propane from a container owned by another company without written authorization (Offenses 1).

### STIPULATED CONCLUSIONS OF LAW

1. Respondent admits extracting propane from another company's tank without permission or written authorization in violation of *Alabama Administrative Code 530-X-2-.16(c)*.

# STIPULATED DISPOSITION

The Board and the Respondent agree that this action will be settled upon the following terms:

- 1. The Respondent agrees to remit a fine of \$ 1000 to the Board within 30 days of the Board's acceptance of this agreement.
- 2. In consideration of Respondent's full and complete compliance with this Settlement Agreement and the terms hereof, the Board agrees to forego the pursuit of its administrative remedies available under Alabama Law, including Ala. Code §9-17-108(b).

3. The Respondent waives his rights pursuant to Ala. Code Sec. 41-22-12; and Ala. Admin. Code Sec. 530-X-1-03 including, but not limited to, the opportunity for a hearing before the Board.

4. This Settlement Agreement shall become effective upon the execution by the parties and upon approval by the Board. Upon approval by the Board, this agreement shall be made a part of the official minutes of the Board's next regularly scheduled meeting. Respondent acknowledges and understands that the official minutes of the Board will be published on the Board's website.

5. Respondent expressly waives all further procedural steps, and expressly waives all rights to seek judicial review or to otherwise challenge or contest the validity of the Settlement Agreement, the stipulated facts, conclusions of law and impositions of discipline herein.

#### SETTLEMENT AGREEMENT 2018-02

Suburban Propane in Huntsville, AL (hereinafter referred to as "Respondent") hereby stipulates and agrees, subject to ratification by the Alabama Liquefied Petroleum Gas Board (hereinafter referred to as "the Board") to the following:

#### STIPULATED FACTS

1. Respondent supplied LP-gas to a cylinder filling station that did not possess the required Class F permit (Offenses 1).

## STIPULATED CONCLUSIONS OF LAW

1. Respondent admits supplying LP-gas to a cylinder filling station that did not possess the required Class F permit in violation of *Code of Alabama 9-17-105 (b)(3)*.

## STIPULATED DISPOSITION

The Board and the Respondent agree that this action will be settled upon the following terms:

1. The Respondent agrees to remit a fine of \$ 1000 to the Board within 30 days of the Board's acceptance of this agreement.

- 2. In consideration of Respondent's full and complete compliance with this Settlement Agreement and the terms hereof, the Board agrees to forego the pursuit of its administrative remedies available under Alabama Law, including Ala. Code §9-17-108(b).
